Myroslaw Smorodsky has been involved since 1968 in many diverse areas of the law ranging from criminal defense, to international transactional and litigation matters, to massive class actions involving Nazi Era Slave/Forced Labor claims resulting in billion dollar settlements. Over the years, he has also represented such diverse clients as soviet political prisoners in the 70's and 80's to acting as legal counsel to the

Ukrainian Mission to the UN, the Ukrainian Consulate in New York and to the Ukrainian Embassy after Ukraine declared independence. In 1980, he was appointed by President Carter as a Public Member to the Madrid Conference on Security and Cooperation in Europe and from 2001 to 2006 was advisor to the International Organization of Migration on issues relating to distribution of compensation to slave/forced labor victims of Nazi Era war crimes.
